1. Sri Lanka will host the 16th World Export Development Forum (WEDF), the flagship event of the International Trade Centre (ITC) in Geneva. The Forum will be held in Colombo from 11th to 13th October, 2016.
2. The Forum will bring together over 600 business practitioners from around the world to debate and identify practical solutions that contribute to trade-led inclusive sustainable development. The WEDF brochure is attached.
3. The 2 day forum under the theme "Trade for Success: Connect, Compete, Change" will comprise of Plenary and "In Focus" sessions workshops, Mini exhibition of 50 Sri Lankan companies and B2B meeting programs for 100 Sri Lankan companies.
4. A special feature of this year WEDF is that emphasis has been placed on a dedicated B2B meeting program Parallel to the Forum. The B2B meetings have been scheduled on 11th, 12th & 13th October 2016 at the BMICH, Colombo. The following sectors have been pre-selected for arranging B2B meetings.
