### ***Working sessions or workshops***

Organizers can choose between working sessions or workshops.

- Working sessions are composed of a limited number of panellists introducing the issue and offering their point of view to the audience. A moderator will engage the participants in an open discussion. Interpretation in the three official WTO languages (English, French and Spanish) will be available for these sessions.
- Workshops take the form of informal brainstorming discussions focusing on particular issues related to the Forum's overall theme. There will be no interpretation to allow for better interaction.

### ***Selection process***

Working sessions or workshops at the Public Forum are organized by participants. The WTO will select the best proposals and allocate the sessions. In order to qualify for selection, your organization needs to complete the following requirements: complete the application form below and return it by e-mail to [pf16@wto.org](mailto:pf16@wto.org). **The deadline for receipt of applications is Friday 3 June 2016.** After this date, no applications will be considered.

Please note that the number of available slots is limited. Allocation of slots will be based on creativity, balance between the perspectives of the different panellists, and links to the theme and sub-themes.
