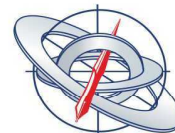

- Deregulation and improvement of business climate (extension of the moratorium on business inspections, VAT payment, regulation of land use);
- Export-import relations development between Ukraine and EU and other regions;
- Simplifying of business in Ukraine;
- Market control and supervision (market regulation);
- Agriculture industry and food production security.

The summit will gather leading economists, representatives of business and government to define the most effective instruments of economic development of Ukraine. B2B meeting with business representatives from Ukraine and other countries of the world, negotiations with representatives of the embassies of countries-strategic partners of Ukraine are planed within the framework of the Summit . The organizers plan the Summit as a permanent platform for formation of strategy of economic development of Ukraine, focused on the dialogue between experts, business and government, on exchanging the best international practices and, as a result, conversion of ideas into action.
